

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OR CANADA WHO ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. THE PROMOTION IS INTENDED FOR LOCATIONS WHERE SWEEPSTAKES ARE NOT PROHIBITED BY LAW AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY, UNITED STATES LAW. 1. **PROMOTION PERIOD:** The entry period for the "CrowdStrike's Protecting Against Directory Attacks Webinar Sweepstakes" ("**Sweepstakes**") begins on July 29, 2022 at 9:00 a.m. Central Time and ends on August 25, 2022 at 1:30 p.m. Central Time (the "**Sweepstakes Period**"). Winner will be randomly selected within 3 business days after the Sweepstakes Period from all eligible entries as more fully set forth below. By participating in the Sweepstakes, each entrant (or his/her parent or legal guardian if entrant is deemed a minor in his/her state of residence) unconditionally accepts and agrees to comply with and abide by these Official Sweepstakes Rules and the decisions of Spiceworks, Inc. ("**Sponsor**"), which shall be final and binding in all respects.
2. **ELIGIBILITY:** Open only to Spiceworks Registered Community Users who are legal residents of the United States or Canada (excluding residents of locations where sweepstakes are restricted or not permitted), and who are 18 years of age or older as of date of entry. A Spiceworks Registered Community User ("**User**") is a person who has joined the Spiceworks community at <http://www.spiceworks.com/community/> before the start of the Sweepstakes Period. Please note that the Sweepstakes registration form includes contact information and CrowdStrike may contact you. If you do not wish to hear from them, just let them know or simply do not enter the Sweepstakes.

Entry Method Two – Users may send a 3x5 card (one per each entrant per envelope for each entry for this Sweepstakes Period) with the words "CrowdStrike's Protecting
