

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OR CANADA WHO ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. THE PROMOTION IS INTENDED FOR LOCATIONS WHERE SWEEPSTAKES ARE NOT PROHIBITED BY LAW AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY, UNITED STATES LAW. 1. **PROMOTION PERIOD:** The entry period for the "Hewlett Packard Enterprise Top Cloud Migration Pitfalls Video Meetup Sweepstakes" ("**Sweepstakes**") begins on May 17, 2021 at 9:00 a.m. Central Time and ends on May 18, 2021 at 11:30 a.m. Central Time (the "**Sweepstakes Period**"). Winner will be randomly selected within 3 business days after the Sweepstakes Period from all eligible entries as more fully set forth below. By participating in the Sweepstakes, each entrant (or his/her parent or legal guardian if entrant is deemed a minor in his/her state of residence) unconditionally accepts and agrees to comply with and abide by these Official Sweepstakes Rules and the decisions of Spiceworks, Inc. ("**Sponsor**"), which shall be final and binding in all respects.
