

## OFFICIAL SWEEPSTAKES RULES

**NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OR CANADA ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. 1. **PROMOTION PERIOD:** The entry period for the "Knowbe4's Hack Waiting To Happen Webinar Sweepstakes" ("**Sweepstakes**") begins on March 24, 2023 at 9:00 a.m. Central Time and ends on April 13, 2023 at 1:30 p.m. Central Time (the "**Sweepstakes Period**"). Please note that the Sweepstakes registration form includes contact information and Knowbe4 may contact you. If you do not wish to hear from them, just let them know or simply do not enter the Sweepstakes.
