

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO SPICEWORKS REGISTERED COMMUNITY USERS WHO ARE LEGAL RESIDENTS OF THE UNITED STATES OR CANADA WHO ARE 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. THE PROMOTION IS INTENDED FOR LOCATIONS WHERE SWEEPSTAKES ARE NOT PROHIBITED BY LAW AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY, UNITED STATES LAW. 1. **PROMOTION PERIOD:** The entry period for the "Palo Alto's Enterprise Security for Any-Sized Business Webinar Sweepstakes" ("**Sweepstakes**") begins on October 7, 2021 at 9:00a.m. Central Time and ends on November 3, 2021 at 2:00 p.m. Central Time (the "**Sweepstakes Period**"). Please note that the Sweepstakes registration form includes contact information and NTT may contact you. If you do not wish to hear from them, just let them know or simply do not enter the Sweepstakes.
