## CYBER RESILIENCE SUMMIT PRESENTED BY MIMECAST REGISTRATION TERMS AND CONDITIONS

The Cyber Resilience Summit presented by Mimecast will be hosted by Mimecast North America, Inc. ## 5. Personal Information.

a. <u>Privacy Policy</u>. We take the protection of your personal information seriously. We will handle your information in accordance with the following provisions and our <u>Privacy Statement</u>. By registering for the Mimecast Summit, you agree that we will use your personal information provided via registration as follows:

IN ANY CASE, THE AGGREGATE LIABILITY UNDER THIS AGREEMENT OF US AND OUR AFFILIATES AND SUBSIDIARIES AND ANYONE ACTING ON THEIR BEHALF WILL NOT EXCEED USD \$100 (OR THE EQUIVALENT IN THE CURRENCY OF THE JURISDICTION WHERE THE PARTICIPANT IS DOMICILED AT THE TIME THE CLAIM AROSE). THE LIMITATIONS IN THIS SECTION APPLY ONLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW.

We will not be liable for any delay or failure to perform any obligation under these Terms where the delay or failure is due to any cause outside of our reasonable control including but not limited to, acts of God, civil or military authority, acts of war, accidents, third-party computer or communications failures, natural disasters or catastrophes, extreme weather, strikes or other work stoppages.

Miscellaneous. The failure by us to enforce any provision of these Terms will not constitute a waiver of such 11. provision nor limit our right to enforce such provision at a later time. All waivers must be in writing to be effective. If any portion of these Terms is held to be invalid or unenforceable, the remaining portions of these Terms will remain in full force and effect. Any invalid or unenforceable portions will be interpreted to effect and intent of the original portion. If such construction is not possible, the invalid or unenforceable portion will be removed from these Terms, but the rest will remain in full force and effect. You will not assign or otherwise transfer these Terms or any of your rights and obligations under these Terms, without our prior written consent. Any assignment or transfer in violation of this section will be void. We may assign these Terms without your consent in connection with a merger, acquisition, or sale of all or substantially all of our assets or to any affiliate or as part of a corporate reorganization. Subject to the foregoing, these Terms will be binding upon and inure to the benefit of the parties and their respective permitted successors and assigns. These Terms are entered into solely between, and may be enforced only by, us and you. These Terms will not be deemed to create any third-party rights or obligations. We may modify these Terms at any time by posting a revised version at the link on the registration page. The modified terms will become effective upon posting. By participating the Mimecast Summit after the effective date of any modifications to these Terms, you agree to be bound by the modified terms. We last modified these Terms on the date identified in the footer of this document. These Terms are the entire agreement between us and you regarding the subject matter of these Terms. These Terms supersede all prior or contemporaneous representations, understandings, agreements, or communications between us and you, whether written or verbal, regarding the subject matter of these Terms. We will not be bound by, and specifically object to, any term, condition, or other provision that is different from or in addition to the provisions herein. These Terms and any disputes hereunder will be governed by the laws of the Commonwealth of Massachusetts, without regard to its conflict of law principles, and any litigation concerning these Terms shall be submitted to and resolved by a court of competent jurisdiction in Boston, Massachusetts.
